## **ORDINANCE NO. 2022-06-01**

# AN ORDINANCE ESTABLISHING PAROWAN CITY WATER RATES AS REQUIRED PURSUANT TO UTAH CODE ANN. §10-8-22.

WHEREAS, Parowan City, Iron County, State of Utah, a body politic, is a municipal corporation organized and established for the purpose of providing municipal services to its residents; and

WHEREAS, Parowan City provides various services to its residents, including culinary and pressurized irrigation services, which municipal water systems are operated, maintained, and improved at a cost to the City, and which rates are established and fixed based upon the costs necessary for providing water services to City's retail customers; and

WHEREAS, Parowan City requires different water rates based upon the nature and type of water services provided, differences in the cost of providing services to a particular area or type of use, requirements to maintain a system differently for certain customers, water conservation policies, and the nature of the water use to its retail customers; and

WHEREAS, Parowan City has historically adopted by resolution various rate schedules according to each service or utility provided, and it is the desire of Parowan City, by adoption of this Ordinance, to give notice to all retail customers of the proposed rate schedule by establishing the various water uses, connection sizes, and base fees including each rate associated therewith; and

WHEREAS, Parowan City desires to enter into a contract with any water user outside its designated service area prior to supply water to the retail customer; and

WHEREAS, Parowan City is required to adopt and it is the desire of the City to provide a more concise and uniform method of establishing water rates which are uniform, clear and readily accessible.

**NOW, THEREFORE, IT IS HEREBY ORDAINED** by the City Council of Parowan City, Parowan County, Utah, that until further ordinance is adopted, the following water rates are hereby established:
