UTILITY SERVICE CONTRACT
(ATTACHMENT TO UTILITY SERVICE AGREEMENT)

CONSUMER RESPONSIBILITY:

Parowan City Corporation, (Seller) shall furnish to the undersigned, (Consumer), those services indicated above at the premises also indicated above. In return for such services, Consumer agrees to pay monthly to the Seller at its office, from the date of installation, and upon presentation of bills therefore, all charges of usage, assessment, service connections, improvements and extensions to the Seller's system necessary to meet Consumer's requirements. Charges shall be made at the regularly established rates for the appropriate classification of service in effect in Parowan City from time to time, and shall be assessed until the consumer requests cancellation of services and fulfills the obligations of this contract.

Consumer agrees to advance the security deposit shown above as may be required by the Seller and it is understood that the Seller may, but need not, apply the deposit upon bills due for prior service and that the right of the Seller to shut off service as herein provided shall exist even though the deposit has not been applied to the payment of past due bills for service. It is further understood that the Seller shall not be required to pay interest on any security deposit. On final settlement of Consumer's account, any unused balance of the security deposit will be refunded.

It is agreed by Consumer that the deposit shall not be considered as an advance payment for any service. Charges and unpaid accounts shall be considered delinquent notwithstanding the existence of the deposit, and Consumer shall not have the right to compel the Seller to apply the deposit to any account to avoid delinquency.

Should Consumer change locations and occupy a subsequent or an additional location within Parowan City, Consumer shall notify Seller promptly of such change of address, and hereby authorizes Seller to note such change of point of delivery in Seller's records. This contract and consumer's obligation to pay for the service furnished, shall continue to be binding upon consumer at all subsequent and additional locations within Parowan City where services are furnished to Consumer.

Consumer shall permit Seller's authorized representatives to enter the Consumer's premises at all reasonable times for purposes connected with the services covered under this agreement.

Consumer warrants that all information supplied in this contract is true and correct and understands that false and misleading information shall be cause for Seller to deny or cancel service and demand immediate payment of any amounts due.

DELINQUENCY:

Payment of the charges made pursuant to this contract shall be due immediately upon billing and shall become delinquent on the 20th day of the month following the period for which billing is made. A penalty of five (5%) percent per month on the unpaid balance will be added to delinquent accounts. Consumer agrees to

pay reasonable expenses of collection, including attorney's fees and court costs, should it become necessary to collect the charges made to consumer's account.

The Seller may terminate service through proper legal procedures at any time the Consumer is delinquent in payment of this account and shall not be liable for any damages resulting from such termination.

If services are terminated by the Seller because the account is delinquent, the Consumer will also be required to pay a connection fee for each service needing to be reconnected, as may be required by the rules and regulations of Parowan City then in effect.

TERMS AND CANCELLATION:

Consumer shall continue to pay and be responsible for payment of all amounts charged pursuant to this Agreement to the premises indicated above and to all subsequent locations to which services are furnished by Seller for Consumer until Consumer's obligation for payment is terminated in one of the following ways:

1. By a request by Consumer to have the services terminated at the location indicated above (pursuant to which Seller shall physically terminate the service thereto); or
2. By termination by Seller of services pursuant to the provisions of this agreement or the rules and regulations of Parowan City; or,
3. By the proper assumption of the payment obligations by another party whom Seller has approved and who has also executed a utility service contract for the premises indicated above.

SELLERS RESPONSIBILITY:

The Sellers shall use reasonable diligence to provide constant and uninterrupted services to the Consumer, but if such services shall fail or be interrupted or become irregular through any cause beyond the reasonable control of Seller. Seller shall not be liable for any damages resulting from such failure, interruption or irregularity. The Consumer agrees to the above terms and conditions and is bound by the Rules and Regulations adopted from time to time by Parowan City, and acknowledges that each of the undersigned has joint and several liability to Seller for all obligations incurred at the location during the term of the contract.

This contract shall be binding upon the Seller only after it has been approved by the City Treasurer or such other agent of the Seller as the Seller may appoint.
